

ORDINANCE NO. 885

AN ORDINANCE amending rates for garbage service.

THE CITY COUNCIL OF THE CITY OF OROVILLE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Section 8.12.130 of the Oroville Municipal Code, which provides as follows:

8.12.130 Collection, disposal – Charges. Commencing with the charge for the month of January 2007, and as billed on January 31, 2007, and monthly thereafter, the charge for garbage service and collection shall be as follows:

Charges for additional cans or pickups shall be on a monthly basis and billed to residences and businesses monthly and shall reflect the charges for extra cans and pickups during the preceding month and shall be billed on such monthly statements as hereinabove set out.

Section 2. Section 8.12.140 of the Oroville Municipal Code, which reads as follows:

8.12.140 Dumpster rental. Dumpsters may be rented from the city when available. All dumpster rental fees shall be on a per-month basis and shall be in addition to the normal dumpster pickup/collection charges for refuse. Dumpsters may be rented for temporary construction or cleanup projects. Fees for such use shall be calculated monthly with a minimum charge of one month and a twenty-dollar pickup and delivery fee for temporary use of ninety days or less.

Monthly dumpster rental fees are established as follows:

is hereby amended to read as follows:

8.12.140 Dumpster rental. Dumpsters may be rented from the city when available. All dumpster rental fees shall be on a per-month basis and shall be in addition to the normal dumpster pickup/collection charges for refuse. Dumpsters may be rented for temporary construction or cleanup projects. Fees for such use shall be calculated monthly with a minimum charge of one month and a twenty-dollar pickup and delivery fee for temporary use of ninety days or less.

Monthly dumpster rental fees are established as follows:

1 ½ cubic yard	13.00
2 cubic yards	15.00
3 cubic yards	27.00
4 cubic yards	38.00
6 cubic yards	48.00

Section 3. This ordinance shall become effective from and after its passage by the council, approval by the Mayor and five days after publication of this ordinance, or a summary, as provided by law.
